## 3. ARTICLES TAKEN OUT OF ORDER:

- A. Scout Addition Consideration- Per Vern Labbe- The Board supports the concept of a scout addition onto the existing recreation building. However, the Board feels it is necessary to ensure the Rec building is structurally sound and capable having such an addition built. Mr. Labbe will be in contact with James Caron II for a building inspection. Information gleaned from the site visit will be brought back to the Board for further consideration.
- B. Pelletier Road- Per John Ezzy- tabled to next meeting
- C. Equipment repair update- Per James Caron II- Truck #2 is in need of rust repair to the dump body. We received two bids on metal. A. Mcquarrie made a motion to go with Gary Gagnon for \$1,300 plus an additional \$100 to cut the metal. Seconded by C. Bernier. All in favor. **APPROVED**

- James Caron II will look into pricing options for a newer dump to replace the failing one on Truck #1. The options will be discussed at a future meeting.
- D. 2012 Road Improvement Plan- Per James Caron II- A motion was made by Andrew Mcguarrie to go with the 2012 paving plan as presented. The plan included paving Sirois, Michaud and Valley View for a total of 289 tons of asphalt. We will advertise for one week. Seconded by Clarence. All in favor.
- E. 2012 Equipment Rates- Per James Caron II- A motion was made by Andrew Mcquarrie to go with the lowest bidder, CL Roy and Sons. If CL Roy is not available than we will go with the second lowest contractor. Seconded by Camille. 3 in favor 1 abstention due to conflict of interest. APPROVED

It states that the Tax Collector/Treasurer is to apply any tax payment received from an individual as payment for any property tax against outstanding or delinquent taxes due on said property in chorological order beginning with the oldest unpaid tax bill, provided, however, that no such payment may be applied to any tax for which an

abatement application or appeal is pending unless approved in writing by the taxpayer.
