Craig Lawrence was present to discuss his pending petition with the town of Frenchville to repeal articles 3, 4, 5, 6, 7, and 8 of the Medical Marijuana Ordinance.

#### 6. NEW BUSINESS:

- A. Craig Lawrence Petition Special Town Meeting- the Board discussed due to the expense associated with holding a Special Town Meeting they have additional business they would like acted upon at the meeting. Therefore, a Special Town Meeting will take place sometime in September.
- B. Gravel Pit and Department of Conservation Options- Consensus of the Board was the MSAD #33 gravel pit needs to be in compliance with DEP and OSHA regulations while the Army Corp of Engineers use it for the St. Agatha Field of Dreams Project. The Town Manager will look into the gravel pit agreement between the town and MSAD #33 before contacting the Superintendent regarding MSAD #33 assuming responsibility for the pits compliance while the Army Corps of Engineers use it. The Town Manager will contact Father James Plourde to determine if they have available gravel for the town and what arrangements can be made.
- c. 2014 World Acadian Congress Rental Policy- Andrew McQuarrie motioned to accept the 2014 World Acadian Congress Rental Policy giving a 15% donation to associated rentees. Seconded by Paul Bernier. All in favor. APPROVED.

The Board will review this again in early January 2014 to make a decision if it is a viable solution.
