#### 6. <u>NEW BUSINESS</u>:

- A. Regional Wastewater Project Progress- The Town Manager asked for and received a copy of the contractor's timeline for construction. She has forwarded a copy to Steve Young and James Caron. They will be conducting periodic inspections and keeping a digital record of the work. The digital record will be kept on file at the town office. If any issues arise Steve or James will contact the Town Manager for remediation steps.
- B. Updated Emergency Management Plan- The Town Manager handed out an updated copy of the town's emergency management plan. The last version of the plan was dated 2003. This document is to be reviewed by each selectman and amended as deemed necessary. Paul Bernier mentioned Vern Ouellette, Aroostook County's Emergency Management Director was pleased with the Town Managers attention to detail and diligence to accomplish this plan for the town of Frenchville.

## 7. <u>UNFINISHED BUSINESS</u>:

A. Pelletier Avenue ATV Trail Consideration & Church Ave Trail-Consensus of the Board was the Pelletier Avenue ATV access route not be considered a town issue. This access route was turned down by the Frenchville ATV Club. The club currently maintains an alternative access route and recently CL Roy & Sons completed restoration work on that section of trail. The Game Warden will enforce state law for any violators using the Pelletier Ave as ATV access.

Paul Bernier made a motion to rescind ATV trail access on Church Avenue to the Frenchville ATV Club. The ATV Club no longer requires the access as the Fort Kent ATV Club has found an alternative route. Seconded by Camille Bernier. All in favor. APPROVED

- **B. Community Center Project Progress-** The Town Manager handed out an updated budget summary. Currently, just over \$8,000 remains as a fund balance for the project. All current project work is on time.
- **C. Safe Alternatives Appeal Update-** Consensus of the Board was to continue with litigation as discussed with Attorney Costlow at the August 21<sup>st</sup> meeting.
