 CALL MEETING TO ORDER: Percy Thibeault called the meeting to order at 5:07 p.m.

**A. Minutes of 8/7/12-** Paul Bernier motioned to approve the minutes of 8/7/12. Seconded by Camille Bernier. All in favor. APPROVED.

**B. 2012 Municipal Valuation Return-** Reviewed and signed by the Board **C. Maine Municipal Bond Bank Certificate-** The Town Manager briefed the Board that the MMBB is reviewing current interest rates to see if there is an opportunity to refund current outstanding bonds held by MMBB and to pass the potential savings on to the town. The signing of the certificate allows for the refunding issue. Paul Bernier made a motion to authorize the Treasurer to sign the certificate of local unit as to arbitrage and use of proceeds of local unit loan. Seconded by Camille Bernier. All in favor. APPROVED.

Paul Bernier made a motion to go into executive session at 5:16 p.m. pursuant to Title 1, M.R.S.A., Section 405, Sub-section 6 E to discuss pending litigation with attorney Fredrick Costlow. Seconded by Camille Bernier. All in favor. APPROVED.

Paul Bernier declared executive session adjourned at 6:02 p.m. As post executive session action the Town Manager will send Attorney Costlow a copy of all exhibits on record at the town office.

## 3. ARTICLES TAKEN OUT OF ORDER:

- A. Community Center Bid Opening- Two bids were received for the community center siding and central air projects. JBBC Inc. submitted a bid for the exterior siding project. The bid amount was \$26,000. A motion was made by Paul Bernier to award JBBC Inc. the siding bid for \$26,000. Seconded by Andrew McQuarrie. All in favor. APPROVED. Ken L. Electric submitted a bid for the central air project for \$11,870. Andrew Mcquarrie made a motion to award Ken L. Electric the bid for \$11,870. Clarence Roy seconded. All in favor. APPROVED. The Town Manager requested a motion for the used windows. There was a contractor who wanted a few. Andrew Mcquarrie made a motion for the town to take 5 windows and the remainder could be taken by the contractor. Seconded by Camille Bernier. All in favor. APPROVED.
- B. 2014 World Acadian Congress- Per Lorraine Pelletier- Ms. Pelletier and Don Levesque presented an update on the progress of the 2014 World Acadian Congress. They are looking for a recommendation for a person to take charge or create a committee to make activities happen for 2014. The deadline to submit projects is September 2013. They also requested the Board encourage families in Frenchville to submit applications for family reunions. Percy Thibeault mentioned that the Paradis Family was recommended and encouraged by the Frenchville Board of Selectmen back in 2011.

A. Hill Street Fire Hydrant Replacement – James Caron briefed the Board that the fire hydrant on Hill Street will need replacing in the near future. James will work with Suzie Paradis to see if grant funds are available for this project. The Town Manager asked James to include the associated project costs in the 2013 Public Works budget proposal. James mentioned there is another fire hydrant that will be in need of repairs in the future. The Town Manager recommended that James include a reserve account allocation in his budget proposal for said work.
