### 6. NEW BUSINESS:

- **A. MMA Loss Control Visit of 04/09/13-** The Loss Control Visit of 4/09/13 had three findings. 1. A faulty emergency light in the basement of the community center. 2. A temporary post support in the fire station garage and 3. Alcohol on town premises. The Town Manager has initiated corrective measures for all three findings.
- B. Adoption of the Alcohol and Drug Use Policy- Paul Bernier motioned to approve the Alcohol and Drug Use Policy. Seconded by Andrew McQuarrie. All in favor. APPROVED.
- C. Petition to repeal Article #6- Andrew McQuarrie motioned to deny the petition to repeal article #6 in reference MMA's legal counsel pursuant to Town of Vassalboro v. Frederick & Camille Denico, et al., Sup. Ct. Kenn.Cty., Civ, Action Docket No. 89-517 (Feb. 23, 1990), at p. 3. Thus, the voters of Frenchville have recently voted on the article and it was approved by the majority. Furthermore, the petition wording is not clearly written so as to ascertain what is intended. Seconded by Clarence Roy. 3 in favor. 1 opposed, 1 abstained. Town Manager will draft a notification letter on behalf of the Board of Selection to Craig Lawarence.
- **D. Town Scrap Metal Bid-** Camille Bernier motioned to authorize scrap metal bid advertisement. Seconded by Clarence Roy. All in favor. APPROVED.
- **E. Citizen Complaint-** Bob Ouellette is addressing the Long residence complaint. Information will be forthcoming.
- **F. State Budget TAN authorization-** Tabled at this time.
- G. **Tax acquired property-** All of the town's tax acquired properties have been designated for recreational use and sustainable harvest management for the benefit of the town through the Upper St. John River Organization. Steve Young, President of the organization will prepare a written document for the Selectmen's signatures and this document will be placed with all the corresponding tax cards for future reference.
- H.
